The International Cooperation Division (ICD) of Ministry of Electronics and Information Technology, Government of India has been set up to promote international cooperation in the emerging and frontier areas of Electronics and Information Technology under bilateral, multilateral or regional framework. In order to doing activities specially related to free trade agreement on Digital Trade, G20, G7, SCO, BRICS and JWG follow-up between both sides (bilateral) for identify fruitful outcomes require a dedicated team for continuous and strong follow-up, research, consolidation, deliberations, documentation and preparation of country's position on very critical issues of ICT throughout the year, a PMU is formed. STPI is implementation agency for PMU.

Accordingly, applications are invited from eligible candidates for filling up vacancies of Sr. Consultant (2 nos), Sr. Executive Trade (1 nos), and Consultant (1 nos). The vacancies are proposed to be filled-up on contract basis for a period of three years (To be reviewed on yearly basis extended/terminated depending upon the performance of the candidate). #### **Selection process:**

- (i) Application received by the last date of receipt of application shall be screened. Therefore, applicants are required to go through the eligibility criteria carefully and ascertain themselves regarding their eligibility before applying.
- (ii) After successful screening of application, the screened-in candidate shall be called for Personal Interview.
- (iii) The Candidates must be accompanied with original documents in support of their candidature in original and submit photocopy of a set of testimonials duly self-attested to STPI at the time of interview.
- (iv) The qualification of the candidates must be from recognized University/Institution.

(v) Name of the Applicant in application form must be same as mentioned in the certificate of matric. In case the candidate has changed his name subsequent to matric, the evidence to that effect should be furnished at the time of interview.

## Other general terms and conditions:

- (i) Canvassing/trying to influence STPI/ MeitY employees to secure the job in any manner shall disqualify the candidate.
- (ii) Candidates recommended by the Selection Committee shall be offered appointment.
- (iii) Selected candidate shall be appointed initially for three years which may be further extended based on performance of the candidate.
