Selection process:

Selection for the above posts shall be on Personal Interview basis. Only the completed online applications by the last date of receipt of online application shall be considered for screening and only shortlisted candidates (after screening) shall be called for Personal Interview. (For shortlisting criteria, kindly refer the general terms & conditions (para 11) of the advertisement available of STPI web portal under career section). Candidate recommended by the Selection Committee shall be offered appointment.

General Terms & Conditions:

- 1. Immediate Absorption rule shall be applicable as per Govt. extant rules.
- 2. Candidates those who have applied on Absorption/Deputation basis are requested to provide the necessary documents alongwith document certifying the date of appointment in the present grade and also certificate of equivalency of IDA pay-scale with CDA pay-scale (If applicable) wherever required during the time of filling of online application.
- 3. The candidates evaluated on the basis of CGPA or else method shall have to provide in writing exact Division from concerned University.
- 4. Age shall be reckoned as on last date of receipt of online application (i.e., 27/03/2023). The upper age limit in respect of candidates working in Govt./STPI on regular basis or candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes and persons with disabilities shall be relaxable as per prevailing instructions. Relaxation in the upper age limit shall also be provided to the contract employee engaged by STPI on consolidated monthly remuneration equivalent to the period of their continuous service performed in STPI, which shall not exceed five years.
- 5. The eligibility of the candidates in terms of educational qualifications, experience, age etc. will be determined on the information furnished by the candidate on the closing date for receipt of online applications. No adding information shall be entertained after the closing date of receipt of online applications. Incomplete online applications will <u>not</u> be entertained.
- 6. Number of posts may vary. STPI reserves the right not to fill up any of posts, if it so decides. STPI reserves the right to operate the post(s) of higher grade in the lower grade and to offer the appointment to the candidate in lower grade, in case the Selection Committee recommends.
- 7. Management reserves the right to fix the criteria for short listing the candidates to be called for interview.
- 8. In case any candidate found ineligible on any ground even after his appointment, his service will be terminated immediately without assigning any reason thereof. Candidates are warned that they should not furnish any false/misleading information/document or submit any document which is defective or fabricated or otherwise commit any act of misconduct in submitting the application form or during the course of recruitment. In case any such case is detected by STPI at any stage, during or after recruitment OR in case any candidate found ineligible on any ground, appropriate action shall be taken against the candidate.
